Captain Johvin Perry, Dental Corps Deputy Director, Naval Health Clinic Hawaii Executive Officer, Navy Medicine Readiness and Training Command Pearl Harbor

Captain Johvin Perry was born and raised in Los Angeles, California. He received his Bachelor of Science in Biological Sciences and a minor in Classical Civilizations from University of California, Irvine, Cum Laude. He received his Doctorate in Dental Surgery from the University of California, San Francisco in 1998. Subsequently, he completed a one-year General Practice Residency at Rancho Los Amigos National Rehabilitation Center in Downey, California. He then completed specialty training in Advanced Prosthodontics and Maxillofacial Prosthetics at University of California, Los Angeles. Captain Perry is a Fellow in the American College of Prosthodonics, and American College of Healthcare Executives.

Capt. Perry reported to Naval Hospital Lemoore in 2004 as Staff Prosthodontist and Dental Division Officer. His duties included being the dental representative to the Executive Committee of the Medical Staff, as well as the Pharmacy and Therapeutics Committee.

In 2007, he was assigned to 3rd Dental Battalion Okinawa, and stationed at Evans Clinic, Camp Foster. Responsibilities included being the command



consultant for prosthodontics and head of the regional dental laboratory. While at 3rd Dental Battalion, he also served in capacity as Command Infection Control Officer for the seven assigned clinics. Additionally, he served as the Command Overseas Screening Coordinator/3rd Dental Battalion Representative to the WESTPAC Alliance committee on Overseas Screening.

In late 2009, he reported to Branch Health Clinic Bangor, Naval Hospital Bremerton, as Head, Prosthodontic Division and also served as Puget Sound Naval Shipyard's Dental Annex Head. He was subsequently assigned as Dental Department Head, Branch Health Clinic Bangor, the command's largest Branch Health Clinic and dental department. A persistent patient safety and infection control champion, Capt. Perry's leadership resulted in a Healthcare Failure Mode and Effects Analysis performance improvement project, providing critical input to dental sterile processing for the branch clinics.
